



Privacy Policy

At Enoteca Turi, we are committed to maintaining the trust and confidence of our customers, visitors to our web site and subscribers to our newsletter. Here you'll find information on how we treat data that we may collect from you if you purchase something, visit our website, or subscribe to our newsletter.

Customers

If you purchase something from us, in the restaurant, online or over the phone, we will need to take information related to the sale, including your name, address, delivery contact and address (if different) landline and/or mobile telephone number and email address. This information is securely stored on servers compliant with the General Data Protection Regulation (GDPR) that is effective from 25th May 2018. We may use this information to contact you regarding your purchase, or regarding other products and services that we believe may be of interest to you as a previous customer of Enoteca Turi. We will also need to share your card details and elements of your billing address with card acquirers for the purpose of processing card transactions. This information is not stored on any of our servers.

Visitors to our Website

When someone visits www.enotecaturi.com we use a third party service, Google Analytics, to collect standard internet log information and details of visitor behaviour patterns. We do this to find out things such as the number of visitors to the various parts of the site. This information is only processed in a way which does not identify anyone. We do not make, and do not allow Google to make, any attempt to find out the identities of those visiting our website. The website does not use cookies.

If we do want to collect personally identifiable information through our website, we will be up front about this. We will make it clear when we collect personal information and will explain what we intend to do with it, such as through our newsletter sign up forms. (See below)

Newsletter Sign Up

We collect personal information when you subscribe to one of our Dotmailer mailing lists, either online or in the restaurant. We use that information to let you know about things that might interest you, like tastings, events and loyalty vouchers. We also use it if we need to contact you, and to ensure that our records are correct. We don't rent or trade email lists with other organisations and businesses. We use a third party provider, Dotmailer, to deliver our newsletter. We gather statistics around email opens and clicks using industry standard technologies to help us monitor and improve our marketing.

You can unsubscribe from our mailings by clicking the unsubscribe link at the bottom of any of our emails or by [emailing the restaurant](#), and you can update the details we hold for you on Dotmailer at any time using the links at the bottom of any of our email newsletters.
